

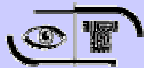

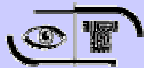

Jean-Pierre Dupuy will be joining Nick Bostrom and Andrew Feenberg as a keynote speaker at our biennial meeting. He is Professor of Social and Political Philosophy at the École Polytechnique, Paris, as well as the Director of C.R.E.A. (Centre de Recherche en Épistémologie Appliquée), the philosophical research group of the École Polytechnique.

SPT board members and the editors of *Techné* are continuing to work very hard on finding a commercial publisher for the journal that would meet the needs of scholars in the philosophy of technology and the Society. Slow progress is being made, as these economic times are obviously not the most conducive for this effort. Still, slow progress is progress nonetheless; and a full update will be given in Enschede.

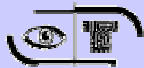

Techné: Research in Philosophy & Technology, the journal of the Society for Philosophy and Technology, is currently welcoming submissions of all styles and approaches in philosophy of technology. The editorial stance of *Techné* is ideologically neutral. There is, however, a unifying theme: a focus on technology, particular technologies, modern or traditional, worldwide, or on social and ethical problems associated with particular technologies. *Techné* aims at being the platform for presenting novel developments and results in academic research on this theme. We therefore seek rigorous, seminal, interesting, creative work and eagerly solicit work from those in fields outside philosophy as long as they offer philosophical perspective.

Submissions will be blind refereed by at least two readers. It is our expectation that authors will be provided with critiques, where, in the judgment of the editors they are deemed helpful. We also seek to have a turn-around time of two months, although this is subject to the cooperation of our referees. We construe philosophy of technology broadly, and we are dedicated to fostering the highest standards in what

Prof. Jean-Pierre Dupuy (École Polytechnique, Paris, Director of research at the C.N.R.S. (Philosophy) and Director of C.R.E.A. (Centre de Recherche en Épistémologie Appliquée))

Posters will be accepted on the basis of a submitted abstract. An abstract must be about 250 words in length) and submitted via email (spt2009@gw.utwente.nl) as embedded plain text or an attachment in RTF or WORD (no docx) or PDF format. Abstracts must be submitted no later than April 31, 2009. Authors will be informed of the decision by May 15, 2009.

The SPT conference series is recognized as the premier international event in philosophy of technology, with delegates from all over the world. Conferences are held every 2 years, alternating between Europe and the United States. SPT 2009 is the 16th conference in the series.

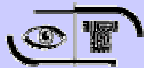

4. Call for Invitations to Host SPT 2011

The SPT Board of Directors invites proposals to host the SPT meeting in 2011. Following past practice, it is anticipated that this meeting will take place in North America, but invitations to host SPT 2011 in other locations are also welcome.

Invitations should include the following details:

- A brief description of your institution and why it would be a good choice for this meeting.
- Anticipated conference dates.
- Anticipated number of registrants.
- Travel information: What airport will conference participants use? Are there direct flights to this airport from major US and international cities? How far is the airport from the conference location? Will the host institution arrange transportation from the airport, or will participants be responsible for getting to the venue on their own?
- A description of the facilities available for the conference. How many rooms will be available for our use? What is their seating capacity? Where will group meals take place?
- Lodging information: How many rooms will be available for conference participants? What will be the anticipated costs of the lodging? Will lodging be on or off campus? If off-campus, how far away, and will transportation be available for participants to get from their lodging to the campus?
- An estimate of the conference registration fee, and a description of the costs to be included in it.
- A budget estimate, including a detailed breakdown of institutional and other expenses (eg keynote speakers, group educational/social activities, etc.). Please provide an explanation of how the costs will be covered, including



anticipated revenue from registration fees, amount needed from the society, and institutional support. (All budgetary information should be given in US dollars.)

- A letter of commitment of institutional support is encouraged to accompany the invitation.

Invitations to host SPT 2011 may be sent to Diane Michelfelder at any time, but preferably no later than 15 May 2009. Invitations may be submitted electronically (to michelfelder@macalester.edu) or by surface mail to the Department of Philosophy, Macalester College, 1600 Grand Avenue, Saint Paul, Minnesota 55105-1899 USA. The SPT Board will consider the proposals received at their next meeting; and it is anticipated that the host institution will be announced at the conference in Enschede. 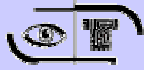

Biennial Meeting, 12-16 July 2009, Brisbane, Australia

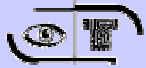

ISHPSSB brings together scholars from diverse disciplines, including the life sciences as well as history, philosophy, and sociology of science. The ISHPSSB biennial summer conferences are known for their innovative, transdisciplinary sessions and for fostering informal, cooperative exchanges and on-going collaborations among a variety of international scholars. This will be the first meeting to be held in the southern hemisphere. The aim of the conference is to facilitate the exchange of research ideas and results across a range of fields. The submission of papers and sessions on any topic within the society's scope is welcomed. We also encourage the submission of posters, workshops, and general interest sessions based on themes identified in session proposals. It is our goal to develop a program that will allow maximal interactions, while also giving people the chance to present their ideas to their colleagues.

The Philosophy of Identity in the Virtual

Symposium 6, April 23, 9-12 AM / 2-5 PM

Difference, Relation and Identity are three notions that are fundamentals for the success of Virtual Reality technologies (VR and AR). The aim of this symposium is to conceptualise the Identity of an individual as a scientific concept whilst acknowledging the fact that Identity cannot be studied without considering the other two notions. The pros and cons of designing identities for or within VR become obvious upon admitting that representing any Self will be interpreted at some point by someone having his own values, opinions and experience in life. Members of our society that self-procure, attribute or redistribute Identity in the Virtual World bring about psychological enquiries in relation to user intentionality, specific uses of VR applications or general modifications to our ways of communicating. Usability issues addressing the problem of Identity have not yet been integrated into long-term visions of society and our needs. The Chair of the session is thus open to all existential, ethical and epistemological issues having to do with Identity in Virtual Communities. Submission of full papers: January 19, 2009

Die fünf Sinne der Wissenschaften

Gemeinsame Jahrestagung der deutschen Gesellschaft für Wissenschafts- und Technikforschung (GWTF) und der Swiss Association for the Studies of Science, Technology, and Society (STS-CH)

am 27./28. November 2009 in Tübingen

Der Rolle von Bildern im Erkenntnisprozess ist in den letzten Jahren eine rege Aufmerksamkeit aus verschiedenen Bereichen der Wissenschaftsforschung zu Teil geworden. Während diese Diskussion anhält, rücken zunehmend auch andere sinnliche Erkenntnispraktiken in den Fokus. Welche Rolle akustische, haptische, olfaktorische, gustatorische und auch visuelle Wahrnehmungen in den Wissenschaften spielen, soll im Zentrum dieser Konferenz stehen. Dies kann entlang verschiedener Fragestellungen geschehen. Einerseits können instrumentelle Praktiken dahingehend untersucht werden, in wie weit sie die sinnliche Erfahrung reduzieren, wenn etwa Krankheiten stärker nach Laborbefunden diagnostiziert werden als durch das Fühlen, Riechen, Schmecken oder Sehen. Andererseits können Technologien auch helfen, Daten in neuer Weise sinnlich aufzubereiten, etwa Unhörbares hörbar zu machen oder akustische Phänomene in grafische Darstellungen zu verwandeln. Nicht zuletzt wurden wissenschaftliche Instrumente aus dem Grund entwickelt, die körperliche Begrenzung der menschlichen Wahrnehmung zu überwinden. Eine weitere Fragerichtung ist, in wie weit beispielsweise visuelle oder akustische Repräsentationen geeignet sind, Disziplingrenzen zu überschreiten, interdisziplinäre Kooperation zu ermöglichen und nicht zuletzt auch die Kommunikation wissenschaftlichen Wissens über die Wissenschaft hinaus zu ermöglichen. Hierzu laden wir sowohl Vorträge ein, die sich aus Perspektive der wissenschaftlichen Praxis mit der Art und Weise der sinnlichen Erkenntnis beschäftigen, als auch Vorträge, die sich aus Perspektive der Wissenschaftsforschung konzeptionell mit den veränderten epistemischen Praktiken auseinandersetzen. Die Probleme der Analyse und der Kommunizierbarkeit visueller und nicht visueller Daten und die Frage nach dem epistemischen Gehalt und der Überzeugungskraft von unterschiedlichen Repräsentationsformen stellen auf der Seite der wissenschaftlichen Praxis neue Anforderungen. Gleichzeitig spiegeln sich diese Spannungen in den Beobachtungen der Wissenschaftsforschung wieder, wenn nicht mehr allein schriftlich und bildlich festgehaltene Diskurse analysiert werden können, sondern die sinnlichen Praktiken in den Laboren in textlich/bildlicher Form gefasst werden müssen. Während die audiovisuellen Möglichkeiten der neuen Medien zumindest nach der visuellen auch die akustische Vermittlung erleichtern, so sind der Verbreitung von haptischen, olfaktorischen und gustatorischen



Wahrnehmungen noch enge Grenzen gesetzt. Inwieweit die neuen bzw. neu entdeckten Erkenntnispraktiken die Theorien der Wissenschaftsforschung herausfordern und inwieweit sich die Praktiken interdisziplinärer Forschung oder die Kommunikation „nach Außen“ durch die Verknüpfung instrumenteller Erkenntnis und sinnlicher Erfahrung verändern, soll in einer interdisziplinären Diskussion empirisch wie theoretisch eingefangen werden.

Cultures as Human Hybridization

Biological and mechanical components are merging. The 'technological artefact' has become a relative notion. Computer-compelled technology is drawing closer to human life as we experience it. Human Life will undergo further movement towards technology. It would seem that the further scientists humanise technology, the more making humans into artefacts becomes possible. Since the outburst of the Industrial Revolution in Europe, attempts to explain human cognitive life away have been on the increase; the idea is to render acceptable the organisation of manifest (more or less biological) components whose human-like behaviour is guided thanks to various calculations. Whether 'building up' the Machine or 'breaking down' the human being, ambivalence prevails in the hearts of all when it comes to future issues: do we or don't we have the right to create certain things? What are the key future issues that involve the evolution of our machines and our very persons? And what do we wish to become tomorrow? Surely there are realistic goals to the activities listed above. It has now become necessary to seriously analyse the "fringe-like aspects" of the use of technology to modify human life (emergent future states & immersion into the unknown). For many, the humanisation of technology and rendering human life more technical in nature go hand in hand, constitute opposing forces, or at least occur on the same practical terrain.

Therefore, over and beyond confirmations and refutations of the humanisation-technicisation relation that exists between Society and Technology, whatever its nature, we solicit papers exploring the Philosophical, Ethical and Epistemological



aspects of the simulation/modification of human cognitive and physical processes and states for this informal Symposium to be held in Laval France. The most promising will be reviewed in view of being published as book chapters in a quality publication.

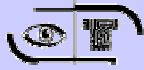
